From the Bench

Since its inception as a pilot program in the spring of 2010, the St. Joseph Superior Court has been operating a mortgage foreclosure settlement program designed to afford homeowners a chance to reinstate defaulted mortgages and avoid foreclosure. The program is available to homeowners whose primary residential mortgages have been the subject of a foreclosure action initiated in either the St. Joseph Superior or Circuit courts. Eligible participants engage in a series of facilitated telephonic and in-person settlement conferences at which various options for avoiding foreclosure are discussed and pursued. Resolutions have included loan modifications in which interest rates or principal balances have been reduced, the application towards past due and future mortgage payment obligations of funds from settlements with large mortgage lenders, and, in cases where the home cannot be saved, *in rem* resolutions, deeds in lieu of foreclosure and negotiated short sales. The conferences have been facilitated expertly and effectively by Judith Fox, William Wilson, James Millstone and Joseph Forte.

- 1224 homeowners have availed themselves of this program with good success. As to those 930 cases in which the process has been completed:
 - Approximately 55 percent (359) of those homeowners eligible to participate and who remained in the program (652), reached agreements.
 - Approximately 31.5 percent (293) of those homeowners eligible to participate and who remained in the program were unable to reach a workout.
 - Settlement was not reached nor the settlement process concluded to a point where it was concluded that no workout was possible in 278 cases. These cases included situations where the settlement conference process was terminated due to program ineligibility, bankruptcy, the failure to participate or voluntary withdrawal from the program.
 - 294 cases remain in the program.

The settlement conference program will remain in effect through 2014. Its success would not have been possible without the commitment of the facilitators and the support of the St. Joseph County Clerk, Indiana General Assembly and the Supreme Court's Division of State Court Administration.

CLERK’S CORNER

Notice of Extension of Policy Governing the Filing of Mortgage Foreclosure Actions in St Joseph Circuit & Superior Courts

Effective January 1, 2014, Plaintiffs filing a new mortgage foreclosure action will be required to provide:

- * One (1) additional, stamped, addressed envelope with not return address information, for each individual defendant (not including any corporation/entity) named as a defendant.
- * A service list, including name, address and telephone number if available for each defendant.
- * This is an extension of the policy adopted April 15, 2010 by the St Joseph Circuit and Superior Courts.

The service list and additional envelopes must be together. Failure to comply with this policy will delay the processing of the case by the Clerk until compliance is achieved.

Indiana Appellate Rule 9(A)

The two-year “location filing grace period” for filing Notices of Appeal **ends at midnight on December 31, 2013**. Beginning January 1, 2014, Notices of Appeal may only be filed with the Clerk of the Supreme Court, Court of Appeals, and Tax Court. Notices of Appeal **will not be accepted** in the St. Joseph County Clerk’s Office.

The Supreme Court has asked us to remind you about an important rule change.

Starting **January 1, 2014**, Notices of Appeal may only be filed with the Clerk of the Supreme Court, Court of Appeals, and Tax Court.

Indiana Appellate Rule 9(A) was amended effective January 1, 2012. The amendment provided that Notices of Appeal may no longer be filed with the clerk of the trial court or administrative agency from which the appeal is taken. A two-year grace period has been in effect for attorneys to have time to get adjusted to this important procedural change. The grace period ends at midnight on December 31, 2013.

The failure to file a Notice of Appeal with the Clerk of the Supreme Court, Court of Appeals, and Tax Court by the applicable deadline forfeits the right to appeal. Given what is at stake if Appellants attempt to file Notices of Appeal in the wrong place, the Court is asking bar associations to encourage members to read the following rule: http://www.in.gov/judiciary/rules/appellate/index.html#_Toc344995669
