Sealing & Expunging Conviction Records

On July 1, 2013, **IC 35-38-9 (HEA 1482)** became effective. This new law has drastically changed the expungement and restricting access of criminal cases process. A memo received from the Division of State Court Administration states, "As to petitions filed under **IC 35-38-9-1** (sealing of an arrest record that did not result in a criminal conviction or juvenile adjudication or the conviction or adjudication was vacated on appeal): If a case was filed and there is an existing case number, the petition should be filed under the existing criminal case number. If there is no existing criminal case (because the arrest did not result in a case), the petition should be filed as a new MC case." No filing fee is assessed according to the statute.

"Under **IC 35-38-9-2**(conviction for a misdemeanor/class D felony reduced to misdemeanor), **IC 35-38-9-3** (a conviction for D felony with some exceptions), **IC 35-38-9-4** (more serious felony with some exceptions), and **IC 35-38-9-5** (a felony involving serious bodily injury or committed by an elected public official with some exceptions): An MI case is to be opened for the petition and **normal civil filing fees are to be assessed** (\$141.00) According to statute no waiver or reduction of fees may be received by the defendant. Petition is to be assigned to the sentencing court.
